- Country Saddle (Walk, slow rack, country saddle gait, Open tack) No Leg Gear 5.
- Juvenile Pleasure (17 and under Walk & pleasure gait, Open tack)No Leg Gear 6.
- Keg Shod Racking (3 gaits, Open Tack, NOT judged on speed)Boots Allowed 7.
- Flat Shod Racking (3 gaits, Open Tack, NOT judged on speed)No Leg Gear 8.
- Country Pleasure (Walk, country pleasure gait, Open tack) No Leg Gear 9.
- Go As You Please (Walk, favorite gait, Open tack) No Leg Gear 10.
- 11. Open Speed Racking (3 gaits, English tack, Bell boots only, no leg gear)
- Juvenile 2x2 Pace Race (17 and under) Open tack, all pacing gear allowed 12.
- Ladies 2 X 2 Pace Race, Open Tack all pacing gear allowed 13.
- Mens 2x2 Pace Race, Open Tack, all pacing Gear allowed 14.
- Speed Racking 2 X 2 race (open tack, boot allowed no leg gear) horses must hold form 15.
- Championship 2x2 Pace Race (Open tack, all pacing gear allowed 16.
